Important Information about Tuition Waivers:

Employee Records enters tuition waivers in the Bursar's Student Information System (Banner) as they are received. However, Banner requires two additional processing steps before the waiver credit is actually applied to your Bursar account.

- First, any waivers entered during the week are transferred to the Bursar system during the weekend process. This is only done once per week.
- Second, waiver credits are not scheduled to post to your account until approximately 10 days before each semester begins. It is only at this time that your accounts will reflect the waiver credit.

Your Bursar bill will not reflect the tuition waiver credit until after these processes are complete (even if you have submitted your waiver application and it has been entered in Banner).

Application for Tuition Waiver For Dependent of Deceased SIU Employee Southern Illinois University Carbondale

- Surviving spouses and dependent children of deceased SIUC employees shall be eligible for educational assistance in the form of tuition waivers. Provided that such dependents meet admission requirements, they shall be eligible to enroll in credit courses and in undergraduate, graduate or professional degree granting programs and receive tuition waivers for a period not to exceed eight semester of registration, subject, in the case of dependent children, to the limitation noted in paragraph 5 below.
- 2. For the purpose of this policy, a "deceased University employee" shall be defined as one who at the time of death was in active pay status, in retirement status, or in disability status and who had served the University for at least 5 years in a full-time capacity.
- 3. In order to be eligible for a tuition waiver, children must be natural born or adopted children or the natural born or adopted children of a spouse who were considered dependents of the deceased employee for Federal Income Tax purposes. Foster children who were supported by and lived in the home of the deceased employee for at least five years and were considered dependents for Federal Income Tax purposes are also eligible.
- 4. Spouses and children shall not be eligible for the tuition waiver if they are employed by the University in any capacity other than as student employees or are receiving aid under any educational grant, aid program, fellowship, or scholarship providing tuition reimbursement.
- 5. Children as defined shall not be eligible for participation in the tuition waiver program if they have passed the age of twenty-two at the time of death of the employee unless they are enrolled in the University at the time of such death. Eligibility of dependent children shall terminate at the age of twenty-eight.

** **Please note--**The application deadline for tuition waivers for each academic year is August 31. (Example: The deadline for Fall 2007, Spring 2008 and Summer 2008 waivers would be August 31, 2008.)
